Elderly man struck by car in crosswalk on Friday

A vehicle hit a roughly 70-yearold man while he was crossing East Second Street in a crosswalk near North Vine Avenue around 7 p.m. Friday, police said.

Dallas Wilson, a public information officer for Tucson Police Department, said the vehicle was traveling eastbound and was being tailgated by another car. The driver was checking his rearview mirrors and did not see the man beginning to cross the street, Wilsion said.

The driver reportedly looked up and saw the man in front of him and was unable to stop before hitting the man, Wilson said.

Tucson Fire Department transported the man to a local hospital. He had with several injuries, Wilson said.

Sgt. Tim Beam, TPD traffic investigation division, said the elderly man was in critical condition and had not heard an update of the status recently, reports stated. University of Arizona Police

University of Arizona Police Department initially responded to the scene with TFD and had the intention to investigate, said Sgt. Eugene Mejia, UAPD spokesman.

Mejia said the man's injuries appeared serious and possibly life threatening, so UAPD paused its investigation and turned the case over to TPD, reports stated.

Impeachment hearing delayed

Charges not filed in time; senators will re-file in spring

The impeachment hearing that was scheduled for tonight's ASUA Senate meeting was postponed yesterday be-

cause of time regulations in the Associated Students of the University of Arizona constitution and Supreme Court Rules of Procedure, according to an official ASUA statement.

The constitution, Article VI, Section V, requires any impeached person to be tried within two weeks of charges being filed. Rules of procedure also prohibit the Supreme Court from hearing cases within three weeks prior to the first day **HEARING, page 12**

ASUA can't confirm suspected meetings

Bernsen: Student gov't officials met to oust me

Student government officials said yesterday they were unaware of any secret meetings conducted to oust President Cade Bernsen, who said students working within ASUA have fabricated sexual harassment charges against him.

Bernsen was accused of violating the UA Student Code of Conduct last week after two women working within the Associated Students of the University of Arizona filed complaints against the president saying he sexually harassed and intimidated them.

The women said Bernsen made comments such as "nice rack" and inappropriately touched them while in the student government offices.

Bernsen called the accusations "completely false" in a statement given to the Arizona Daily Wildcat and countered that the accusations were

Commencement calm compared to last year Graduation ceremony undergoes only 'tweaking'

This month's commencement ceremony will have few changes compared to last year, which was marked by a heated battle to keep the December ceremony from being canceled, officials said.

Planning has gone much more smoothly this year, unlike last year's roller coaster ride that left organizers scrambling at the last minute to get information about the event out to the public, said Alexis Hernandez, associate dean of students and chairman of the commencement operations team. "We really hate to throw major changes at commencement,"Hernandez said.

The committee in charge of changes to commencement hasn't met since October because there has been nothing on the agenda except "minor tweaking," said Kathy Hawkes-Smith, a member of the Commencement Operations Team.

"Commencement is an evolving ceremony," she said. "Part of what we're trying to do is look at what others do and make minor changes to keep a good flow of the program and keep it moving and interesting."

Every year there are usually one or two additions

part of a scheme to remove him from office.

"There have been ongoing secret meetings by certain individuals to manufacture this attack on me and to force me out of office," Bernsen said in the statement.

ASUA student leaders and one woman who complained against Bernsen said they were unaware of any secret meetings or a larger conspiracy to unseat the president.

Cassi Sonn, administrative vice president, said she didn't know of any meetings, but she wouldn't comment further.

Sen. Matthew Boepple also said he wasn't aware of any organized meetings conducted in private.

There has been no confirmation that secret meetings have occurred, though there are rumors of the meetings, said Jim Drnek, an associate dean of students who serves as ASUA's adviser.

Drnek said he would be looking into whether any such meetings took place.

In an e-mail sent to an ASUA and Faculty
